The regular meeting of the Board of Education of Independent School District No. 484 was held on Wednesday, December 14, 2022 in the High School IT Classroom. The meeting was called to order at 6:00 PM by Chair Matthew Hoheisel.

Motion by Boser; seconded by Thomas and was carried unanimously to approve the following agenda as presented without changes.

Hoheisel moved the adoption of the following resolution:

Member Toops introduced the following Resolution:

RESOLUTION ESTABLISHING COMBINED POLLING PLACES FOR MULTIPLE PRECINCTS AND DESIGNATING HOURS DURING WHICH THE POLLING PLACES WILL REMAIN OPEN FOR VOTING FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A STATEWIDE ELECTION

BE IT RESOLVED by the School Board of Independent School District No.484, State of Minnesota, as follows:

1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for school district elections are those precincts or parts of precincts located within the boundaries of the school district which have been established by the cities or towns located in whole or in part within the school district. The board hereby confirms those precincts and polling places so established by those municipalities.

2. Pursuant to Minnesota Statutes, Section 205A.11, the board may establish a combined polling place for several precincts for school district elections not held on the day of a statewide election. The following combined polling places are established to serve the precincts specified for all school district special and general elections not held on the same day as a statewide election:

Combined Polling Place: PIERZ CITY HALL, 101 MAIN ST. S., PIERZ MN 56364

This combined polling place serves all territory in Independent School District No.484 located in the City of Pierz and the City of Genola; and Belle Prairie, Hillman, Little Falls, Mount Morris and Pierz Townships in Morrison County, Minnesota.

Combined Polling Place: AGRAM TOWN HALL, 12321 LAKE RD., PIERZ MN 56364

This combined polling place serves all territory in Independent School District No.484 located in Agram Township; and Buckman and Morrill Townships in Morrison County, Minnesota; and Graham Township in Benton County, Minnesota.

Combined Polling Place: BUH TOWN HALL, 17782 255TH AVE., PIERZ MN 56364

This combined polling place serves all territory in Independent School District No.484 located in Buh Township; and Granite Townships in Morrison County, Minnesota.

Combined Polling Place: PULASKI TOWN HALL, 24451 296TH AVE., PIERZ MN 56364

This combined polling place serves all territory in Independent School District No.484 located in Pulaski Township; and Platte Township all in Morrison County, Minnesota; and Daggett Brook and Platte Lake Townships in Crow Wing County, Minnesota.

3. Pursuant to Minnesota Statutes, Section 205A.09, the polling places will remain open for voting for school district elections not held on the same day as a statewide election between the hours of 12:00 o'clock noon and 8:00 o'clock p.m.

4. The clerk is directed to file a certified copy of this resolution with the county auditors of each of the counties in which the school district is located, in whole or in part, within thirty (30) days after its adoption.

5. As required by Minnesota Statutes, Section 204B.16, Subdivision 1a, the clerk is hereby authorized and directed to give written notice of new polling place locations to each affected household with at least one registered voter in the school district whose school district polling place location has been changed. The notice must be a non-forwardable notice mailed at least twenty-five (25) days before the date of the first election to which it will apply. A notice that is returned as undeliverable must be forwarded immediately to the appropriate county auditor, who shall change the registrant's status to "challenged" in the statewide registration system.

Upon vote being taken thereon, the following voted in favor thereof: Toops, Sczublewski, Hoheisel, Boser, Thomas;

and the following voted against the same: none;

whereupon the resolution was declared duly passed and adopted and was signed by the Chairperson and attested by the Clerk.
